**A. FREEZER STRUCTURE**

1. Supply, deliver and install Four (4) sided freezer room panels with roof strong enough to hold meat rails as per the specification below:

**B. FREEZER REFRIGIRATION UNIT**

- This unit should be able to drop the temperature of this freezer to negative 20 degrees Celsius when loaded with 3 tons of meat
- Provide light bulbs suitable for the freezer room (these should only be on if the door is open)
- Supply and install the temperature display unit mounted outside on the wall.
