NTINGA 2022/2023 SECOND QUARTER SCM PARAGRAPH 6 REPORT

1. PURPOSE

- [1.1] The purpose of this memorandum is for noting by the Committee, Ntinga's 2022/23 Second Quarter Report on Implementation of Supply Chain Management (SCM) policy as prescribed by paragraph 6(3) of the Municipal SCM Regulations.
- [1.2] The is also to enhance the oversight role [as per paragraph 6(1)] by informing the Committee to consider the performance progress of Ntinga made in this quarter, with respect to adherence to, and innovative implementation of the SCM policy to achieve the objectives of the municipality.
- [1.3] Regulation 6(2)(a)ii of the SCM Regulations, requires the Accounting Officer to report on the annual implementation of the SCM Policy to the Board in order to strengthen the Boards oversight role.

2. SUMMARY

[2.1] Paragraph 6(1&3) states that: The Council of a municipality and the Board of Directors of a municipal entity must maintain oversight role over the implementation of its SCM policy. The accounting officer must therefore, within 10 days after the end of each quarter, submit a report on the implementation of SCM policy to the Executive Mayor of the municipality or the Board of Directors of the municipal entity, as the case may be. These reports must be made public in accordance with section 21A of Municipal Systems Act. This will ensure maintenance of oversight role by the Council and access to municipal information by the communities and public.

[2.2] This report, herein attached as Annexure A, is for noting and will be submitted to the Ntinga Board of Directors in the next meeting.

3. DISCUSSIONS

- [3.1] This oversight role of the Council is meant to address the following priority areas of the municipality:
 - Governance;
 - Compliance with legislation;
 - Operation Clean Audit; and
 - Transparency and Accountability.
- [3.2] Details of awards made are attached as annexures to this memorandum.

4. CONSULTATION

This report has been discussed by Ntinga's senior management.

5. ORGANISATIONAL AND PERSONNEL IMPLICATIONS

There are no organizational or personnel implications.

6. REPRESENTATIVITY

This issue does not apply in this regard.

7. CONSTITUTIONAL AND LEGAL IMPLICATIONS

[7.1] Section 111 of Local Government: Municipal Finance Management Act, 2003 (Act 56 of 2003) prescribes that each municipality and municipal entity must have and implement an SCM policy which gives effect to procurement of goods and services.

- [7.2] Section 21A of the Municipal Systems Act, (Act 32 of 2000) prescribes that certain documents should be made public by the municipality by displaying them at the municipal head office, official website, and/or local newspaper (also notify local community of the place or website address the documents can be obtained). The local communities should also be invited to submit written comments or presentation to the municipality in respect of the relevant documents.
- [7.2] Paragraph 6 of Local Government: MFMA Municipal Supply Chain Management Regulations which prescribes council oversight and submission of SCM Implementation Report within a specific date.

8. FINANCIAL IMPLICATIONS

This report has no financial implications except those that have already been incurred in procurement of goods and services.

The table above indicates that during the second quarter:-

Procurements of the <u>value up to R30 000</u> amounted to R 676,124.45 this figure is up 12% from the last 1st quarter. 89% of the awards made went to supplier in the Eastern Cape this is down from 97% of the last quarter. OR Tambo District awards are 42%.

a) R 506,715.17 of this quarters procurements or 79% went to SMME's.

Procurements to the value of R30 000 to R200 000 amounted to R 889,977.48 down from the R1,093,397.83 achieved last quarter 43% went to suppliers in the OR Tambo Region.

b) R442,276.74 or 49% of the total value went to SMME's

Procurements from transaction value of R200 000 and above amounted to R 6,697,277.28.28 30% were awards made to supplier in the Eastern Cape and 43% from the OR Tambo District. R1,717,785.00 were auctions attended by Adam Kok Farms to supply the Umzikantu Red Meat Abattoir with stock.

- c) 4299,523.86 of the transaction R200k and above went to SMME's
- d) total value of awarded transactions for the quarter is R 5,248,515.92 this is a percentage value of 63%
