- a) Fails to complete fully the bid document or to provide the information requested, or to sign the bid at the appropriate spaces provided or next to errors, his/her/ its bid.
- b) Is found to be a role player or commits criminal act/s including fraud, price rigging, corruption, collusion, or forgery. In the case of an award already made, the award or contract shall be terminated. Or any of its directors or those of the subcontractor or partner:
- c) owe municipal charges/ rates and is in arrears for more than three months,
- d) Where the bidder does not own the property, attach a valid lease agreement between the Lessee and the Lessor that indicates that the lessee is not responsible for property rates and a signed affidavit from the Lessor.
- e) Had during the last five years failed to perform satisfactory on previous contract with municipality or municipal entity or organ of the state after written notice given to perform satisfactorily;
- f) abused the supply chain management of the municipality or municipal entity or committed an improper conduct; and has been listed in the register of tender defaulters and is in the service of the state.
- g) Fails to submit CSD supplier number;
- h) Fails to submit SARS Tax Pin and/or Tax Clearance Certificate
- i) Fails to submit audited annual financial statements of the bidding entity (projects over R10 million);
- j) Fails to submit Joint Venture Agreement or Consortium Agreement, signed and initialed on each page (if applicable).
- k) Original or certified copy of Broad Based Black Economic Empowerment Certification should be attached if not attached no points will be awarded for preference points.
